 - c) If the candidate fails to furnish proof of the stipulated minimum qualifications/eligibility and produce certificates or credentials.
 - d) If any of the produced qualification certificate/s or claims found to be fake, forged or duplicate.
 - e) If any of the produced qualification certificate/s is obtained from an unrecognized institute or University.
 - f) The students qualifying mark in the master degree is less than 55% (in case of General Category) and less than 50% (in case of SC/ST/OBC etc).
 - g) Any other disciplinary action, if any or any other reason as University may deem fit
3. Jurisdiction: Any dispute pertaining to admission, or any matter as a student or alumnus of Manipur International University shall be subjected to the Jurisdiction of the courts situated in the State of Manipur only.
